BY-LAW NO. 3/2019

OF THE

TOWN OF TEULON

Being a By-law of the Town of Teulon to amend the
Waste Disposal Grounds Fees as shown in By-law No. 12/12

WHEREAS By-law No. 4/09 of the Town of Teulon regulated the activities for
the Teulon Rockwood Waste Disposal Grounds;

AND WHEREAS Schedule "A" of By-law No. 12/12 is setting the fees for
disposal of refuse at the Teulon Rockwood Waste Disposal Grounds;

AND WHEREAS Clause 5 of By-law No. 4/09 authorizes that Schedule "A" of
this By-law may be amended;

AND WHEREAS the Town of Teulon wishes to amend the rates as outlined in
Schedule "A" of By-law No. 12/12;

NOW THEREFORE the Council of the Town of Teulon, in Council duly
assembled, enacts as follows:

1. That the rates stated in Schedule "A" of By-law No. 12/12 be now hereby
amended to include the rates as indicated in Schedule "A" to this By-law.
2. This By-law shall come into force and take effect as of July 1, 2019.
